In addition, it will intend to participate actively, as has been done until now, in the UNSDCF evaluation. In addition, the country office will carry out with ONUMujeres the joint evaluation of the “Raices” project, which began in 2022 and will end in 2026, to obtain clear evidence of the results of this project, focused on women and youth from 12 prioritized municipalities. • It is understood that there are still essential information gaps regarding the young population and women from the most vulnerable sectors. During the eighth programme, the mobilization of resources is expected to complement this cost evaluation plan.
