Country Programme priority areas	 In the framework of its 9th Country Programme 2025-2029, the UNFPA Country Office will promote the implementation of four interconnected outputs: Policy and accountability; Coverage and quality services; Adolescence and Youth and Population and data, pursuing the complementarity of interventions across development-humanitarian-peace contexts (NEXUS) and resilience-building interventions, including disaster risk reduction and climate change adaptation. The Programme will aim at closing equity gaps in access to family planning and maternal health, contributing to the prevention of adolescent pregnancy and maternal mortality reduction, in line with national policies. It will also advance efforts for the prevention and care for victims/survivors of violence and harmful practices, particularly child marriage and early unions.
